A TRIBAL RESOLUTION OF THE MUSCOGEE (CREEK) NATION ADOPTING A DECLARATION ON THE RIGHTS OF INDIGENOUS PEOPLES AND DIRECTING SAID DECLARATION INTO THE MVSKOKE LANGUAGE

Be it Resolved by the National Council of the Muscogee (Creek) Nation:

WHEREAS, the United Nations adopted the United Nations on the Rights of Indigenous Rights ("UNDRIP") on September 13, 2007 and the United States, by President Barack Obama, endorsed the UNDRIP on December 16, 2010; and

WHEREAS, the National Council adopted TR 13-013 supporting the UNDRIP; and

WHEREAS, the Muscogee (Creek) Nation recognizes that tribal nations are a vital part of the international indigenous community and empathizes with indigenous peoples whose tribal sovereignty, right of self-determination, preservation of tribal culture and safety and welfare are threatened; and


WHEREAS, the translation of a Declaration on the Rights of Indigenous Peoples into Mvskoke language is an exercise of the Nation's sovereign rights with the ultimate goal of removing the legal and cultural obstacles that prevent the Muscogee people from continuing their traditional and ceremonial life.

NOW THEREFORE BE IT RESOLVED THAT, the Muscogee (Creek) Nation hereby adopts the attached Declaration on the Rights of Indigenous Peoples.

BE IT FURTHER RESOLVED THAT, any of the attached portions of the Declaration on the Rights of Indigenous Peoples that have not yet been translated, shall be translated into the Mvskoke language.

ENACTED by the Muscogee (Creek) National Council on this 24th day of September, 2016.


